

# FREQUENT BUYER PROGRAM

A customer loyalty program that rewards consumers for repeat purchases. For every 10 units purchased of a single product, the consumer receives 1 free unit. All product must be the same size. This offer can be used for bulk packaged goods, and it applies to all L'Avian Plus<sup>™</sup> caged bird and small animal products.

### **Index Cards**

Retailers receive a free supply of L'Avian Plus<sup>™</sup> Frequent Buyer Club cards for their customers. Retailers then complete these cards as customers purchase L'Avian Plus<sup>™</sup> products. Customers are entitled to one (1) free after the purchase of ten (10) of the same product. The retailer then turns the completed card in to its L'Avian Plus<sup>™</sup> supplier and receives replacement merchandise or credit. This program applies to all L'Avian Plus<sup>™</sup> purchases – any product, any size!



As consumers purchase products, store employees complete the

information on the card (including date and time of purchase). Please use one card for each SKU purchased. When the card is complete (10 purchases made), retailers simply give the customer the free merchandise and indicate so on the card itself (in the space provided).

Finally, retailers turn the completed card in to their L'Avian Plus<sup>™</sup> distributor, who will replace the free product at no cost to the retailer. Additional cards are available at any time, so customers can always be earning (and buying) more great L'Avian Plus<sup>™</sup> products!

### **Envelope**

With this method, retailers simply offer a L'Avian Plus<sup>™</sup> Frequent Buyer program envelope to their customers. As in the method above, customers are entitled to one (1) free product after the purchase of ten (10) of the same product. After the customer has collected 10 L'Avian Plus<sup>™</sup> UPC codes, they simply seal them into the envelope and mail it directly to D & D Commodities. In turn, we will mail them a voucher to use in your store. This program applies to all L'Avian Plus<sup>™</sup> purchases – any product, any size!



### **Frequently Asked Questions**

#### What does it cost to register?

Nothing. Registration is FREE, and complete store kits and signs will be sent to you at no charge with complete instructions.

I would prefer to use my own cards or keep track of purchases on the store computer. Is this acceptable? Absolutely. As long as the free product can be documented and the information supplied is the same as on the cards provided by D & D, the retailer will be reimbursed.

# In the Frequent Buyer Program, is there only one product allowed per card?

Yes. Consumers may have to carry more than one card... many do. If more than one product or size is recorded on the same card, the retailer will be reimbursed for the least expensive item.

## How does the retailer receive reimbursement for free product allowed?

Upon presentation of correct documentation, the retailer will receive free replacement product or will be issued credit for the full retailer cost of the free product allowed.

# There is no cost to the retailer. How does the retailer participate?

It's very easy. Simply complete the information below and fax or mail the form to the address below. The retailer will then receive a kit with all the necessary information, instructions and store signs.
